

APRIL 17-19, 2023 | VARANASI

100th Meeting under India's G20 Presidency



Under the theme of 'Sustainable Agriculture and Food System for Healthy People and Planet', the Meeting of Agricultural Chief Scientists (MACS) of G20 nations was held in Varanasi. Addressing the global food security concerns aggravated by the COVID-19 pandemic and climate change, the participants recognised the need for strengthening efforts towards sustainable agriculture and food systems by leveraging science, technology and innovations.

The meeting adopted a Chair Summary cum Outcome Document focussing on major areas of cooperation in agricultural research and development for food security and nutrition, digital agriculture, resilient agri food systems and public private partnership in agricultural R&D.

In a major achievement, MACS 2023 garnered unanimous support for the launch of Millets And OtHer Ancient Grains International ReSearch Initiative (MAHARISHI). This initiative will supplement the efforts undertaken under the International Year of Millets 2023 (IYoM 2023) program initiated by the United Nations General Assembly (UNGA).

Technological advancements have revolutionised the lives of Indians. From facilitating education through online learning platforms and finding employment through job portals, to accessing healthcare via telemedicine and e-pharmacies, and making digital payments, a robust digital economy has enhanced every facet of an individual's quality of life. Built on an interoperable, open-source standards and API, Digital Public Infrastructure (DPI) has also created new opportunities for entrepreneurship and innovation, making India a hub for digital innovation in the region.

The 2nd Digital Economy Working Group Meeting in Hyderabad, Telangana, in mid-April, highlighted the three priorities - Digital Public Infrastructure (DPI), Cyber Security, and Digital Skilling, with the aim to achieve practical, actionable outcomes for the betterment of the world, in particular, the Global South. India's DPI story has shown that it is possible to undertake and successfully implement a financial inclusion model at scale. Aadhaar, the world's largest biometric ID system, enabled 50x more direct transfer of benefits between 2014 and 2022, while India's Unified Payments Interface (UPI) processed 8.3 billion secure, quick, and low-cost transactions in March 2023 alone. Building technology-embedded platforms must be in consonance with driving development for remote, underserved, and vulnerable communities, which is why the G20 Presidency is prioritizing DPI as a key agenda item. The development of a common framework for DPI, including digital identity systems, digital payment systems, and consent-based data sharing systems, will enable low and middle-income countries to design, build, scale, and regulate inclusive, interoperable, and secure DPI.


Similarly, having a common framework for cybersecurity and a shared approach to capacity building among G20 member countries will be crucial in reducing the risk of cyber-attacks. Further, developing a toolkit that defines a common cyber education framework for school and university

curriculums across G20 countries will also help in building a culture of cybersecurity awareness. Prioritizing cybersecurity and adopting best practices will be crucial in ensuring the safety of digital infrastructure and the growth of global economies.

Lastly, digital up-skilling and re-skilling are essential to ensure that the workforce is equipped with the necessary expertise to succeed in a digital economy. According to the World Economic Forum, around 50% of employees globally will need reskilling by 2025 due to the adoption of digital technologies. This workforce must be mobile, versatile, and capable of quickly adapting to changing technological landscapes. To this end, outlining a common reference framework for the mutual recognition of digital skills across borders will be paramount.

As the G20 members continue to work towards creating a digital economy that benefits all, the DEWG deliberations provide a platform for sharing best practices, discussing critical areas, and collaborating towards achieving the G20’s digital economy objectives. I look forward to the next in-person meeting, scheduled to take place in June 2023 at Pune, Maharashtra. ■

In the over 100 meetings held so far under India's G20 Presidency, a dedicated endeavor has been made to present the diversity represented in our country to the delegates who visit India for G20 meetings. A few days before India officially assumed G20 Presidency, Prime Minister Shri Narendra Modi had stated that "the people coming to the G20, even if they come now as delegates, are tourists of the future." This insight has resonated strongly with the people of India, evident from their enthusiasm, as they see these meetings as an opportunity to acquaint delegates with our rich cultural heritage and diversity and tourism potential.

Last month, the second meeting of the

Tourism Working Group brought the delegates to the tranquil Himalayas of Darjeeling, my hometown, where I was delighted to welcome them.

The Tourism Working Group, under India's G20 Presidency, has identified five key priority areas: Green Tourism, Digitalisation, Skills, Tourism MSMEs and Destination Management. The meeting, held in three separate locations of Darjeeling District (Kurseong, Siliguri and Darjeeling town), provided an opportunity for G20 delegates to witness the coexistence of people with nature and in a sustainable manner.

During the two working sessions, G20 delegates deliberated and focused

on a potential roadmap to link the tourism sector with the 2030 Agenda for Sustainable Development, and leverage tourism development for achieving Sustainable Development Goals (SDGs). The inaugural session of the meeting began with an address by Union Minister for Tourism Shri G. Kishan Reddy in which he shared the vision of the Draft National Tourism Policy by the Ministry of Tourism to provide a holistic framework for sustainable and responsible growth of the tourism sector in the country and strengthening tourism to highlight India’s commitment to achieving Sustainable Development Goals 2030.

The Prime Minister has stressed on tourism, along with trade and technology, as the 3Ts for accelerating development in India. In line with this, having been blessed with a diversity of landscapes, climatic conditions, flora and fauna, cultures, and languages, India is capable of providing a host of unique experiences, ranging from lively and vibrant Goa to the peaceful and bio-diverse North East. As the tourism sector faces its own challenges, such as greenhouse gas (GHG) emissions, water consumption, waste management, loss of biological diversity, among others, India’s G20 Presidency has rightly prioritized

Significantly, the Tourism Working Group under India’s G20 Presidency has also given due consideration to developing and diversifying tourism products or ‘niche tourism’, which attract travelers from specific markets both as geographic entities and interest groups. The focus of the first meeting of the Tourism Working Group in Gujarat’s Rann of Kutch in February was on ‘Rural Tourism’ and ‘Archaeological Tourism’, where delegates discussed ways to empower local communities with sustainable livelihoods.





The month of April, 2023 has witnessed 2nd Meeting of G20 Finance Ministers and Central Bank Governors in Washington, DC as well as a series of events which took place mainly under India's G20 Presidency on Digital Public Infrastructure (DPI) where India's achievement

in the field of DPI has been discussed and showcased extensively. During the Spring meetings of the World Bank Group (WBG) and International Monetary Fund (IMF) held in Washington, DC from April 10, 2023 through April 14, 2023 several high-level events were organised on India's achievements on DPI.

IMF in collaboration with DEA, Ministry of Finance also organized a High Level Seminar on "Digital Public Infrastructure (DPI): Stacking up the Benefits" on April 14, 2023 on the sidelines of the IMF-World Bank Spring Meetings. Hon'ble Finance Minister Smt. Nirmala Sitharaman; United Nations Secretary-General's Special Advocate for Inclusive Finance for Development Queen Maxima of Netherlands; Managing Director of IMF Ms. Kristalina Georgieva; Co-chair and Founder of Bill &





Melinda Gates Foundation Ms. Melinda French Gates; Co-Founder of Infosys and Co-chair of India's G20 Task Force on DPI Mr. Nandan Nilekani; and CEO of Paypal Mr. Dan Shulman were the speakers in the event.

The focus of the High level Seminar was on the lessons from mainly India and also from other countries on the transformational power of DPI and ways to maximize the potential of DPI. Hon'ble FM mentioned that DPI enables improving governance, brings ease of doing business, facilitates ease of living for people as well as has the greatest potential in reaching the last mile even under difficult times. The Seminar, based on IMF's paper titled "Stacking up the Benefits: Lessons from India's Digital Journey", was a huge success and witnessed participation from over four hundred delegates of IMF-World Bank Spring meetings.

A separate event was also organized by the IMF on April 10, 2023 on "India's Digital Transformation: A talk with Nandan Nilekani" where Mr. Nandan Nilekani, Co-chair of India's G20 Task force on DPI made a presentation about India's success story in DPI. In her opening remarks at the event, Ms. Kristalina Georgieva, MD, IMF also appreciated India's strength in DPI and its usefulness for advancing financial inclusion rapidly.

On 13th April, 2023, another High Level Event with the presence of Ministers from Rwanda, Kenya and Maldives on "Scaling Up Digital Investment and Innovation to Address Global Challenges" was organized by the

World Bank to amplify the importance of inclusive approaches to advance connectivity, uses of DPI, digital literacy and other enablers for resilience. During the event, major success stories of India in Digital Payments and Digital Identity were shared by the speakers.

Meanwhile, the 2nd G20 Finance Ministers and Central Bank Governors Meeting was also held on April 12-13, 2023 in Washington, DC on the sidelines of the WB-

IMF Spring Meetings. A range of G20 issues including taking forward the work of the G20 priorities for the year including financial inclusion were discussed. Inter-alia, the progress made so far on the presidency deliverable of policy recommendations for advancing financial inclusion and productivity gains by leveraging DPI under the G20-Global Partnership for Financial Inclusion (GPFI) working group was also reviewed.

As such, the series of events on the sidelines of Spring Meetings, 2023 had created considerable buzz about India's achievement in the DPI. ■




India's theme for its G20 Presidency "One Earth • One Family • One Future" signifies the intrinsic connectedness between all living beings and celebrates oneness in the fight against humanity's greatest challenges. The theme also speaks about the importance of One Health, a concept that recognises that this kinship trickles down to the health of humans, animals, and the environment. Each one plays a role in balancing, sustaining, and disrupting the other. The approach first took shape in 2004 under the Manhattan Principles,¹ which recommended an integrated and coordinated effort at the human, animal and environment interface to prevent, detect, and respond to zoonotic diseases. The recommendations have since been updated with the 2019 Berlin Principles² to reflect contemporary challenges, including climate change and antimicrobial resistance.

With countries still recovering from the COVID-19 pandemic, the adoption of this approach is imperative to safeguard the future of our world. The pandemic has also pushed the world to recognize the threat of zoonotic diseases and how easily they can spread across borders and impact global health, economy, and security. For India, One Health features as a priority action item, as evidenced by PM Narendra Modi's words: "Guided by the approach of 'One Earth, One Health', humanity will certainly overcome this pandemic".³

To streamline the country's move in this direction, India's apex biomedical research organization, the Indian Council of Medical Research (ICMR), has taken some decisive strides.

■ **National Institute of One Health (NIOH):** The

National Institute of One Health (NIOH) is being built in Nagpur with the aim of coordinating and integrating research and development activities in One Health, bringing together diverse stakeholders from human, animal, and environmental sectors for better disease control and improved pandemic preparedness. The Institute will have participation from various relevant stakeholders in addition to the Indian Council of Medical Research (ICMR), such as National Centre for Disease Control (NCDC), Department of Biotechnology (DBT), Department of Animal Husbandry and Dairying (DAHD), Indian Council of Agricultural Research (ICAR), Council of Scientific & Industrial Research (CSIR), and the Ministry of Environment, Forest and Climate Change (MoEF&CC). The Institute will have BSL-4, BSL-3, and animal facilities and office space for collaborative working, shared by all partner Departments/Organizations. The Institute will coordinate R&D with other stakeholders such as non-governmental bodies, private sector, international agencies, and academic

units working in One Health in a participatory fashion. The Institute will develop and coordinate activities for epidemic/pandemic preparedness and work to strengthen surveillance systems across sectors. It will also facilitate epidemiological studies, disease modelling, and policies for emerging one health disease.

- **One Health Symposium:** In April 2021, ICMR organized an international symposium titled 'One Health in India: Research informing biosafety, preparedness and response' to drive greater momentum towards the adoption of One Health. Dr Harsh Vardhan, former Union Minister for Health and Family Welfare chaired the event and applauded ICMR's effort of bringing together wide-ranging, multi-sectoral stakeholders for discussion and collaboration on new and emerging zoonotic diseases.⁴ In the symposium, the former Health Minister also announced the constitution of a high-level steering committee for Eco Health Initiatives in India to be supported by the National Institute of One Health.
- **Special Issue of IJMR:** On the occasion of ICMR's One



Health Symposium, Dr Harsh Vardhan launched a special issue of the Indian Journal of Medical Research (IJMR) on One Health⁵ containing original articles, viewpoints, perspectives and reviews from eminent experts in the field. The issue covers perspectives related to One Health, including tribal health and culture, biothreats, challenges of

unknown health threats, animal disease surveillance and food safety, among others.

- **Online Certificate Course:** ICMR's Regional Medical Centre (RMRC), Bhubaneswar has designed an online course named 'Online Certificate Course on 'One Health'' in collaboration with Government of India's integrated platform and portal for online courses (the NPTEL-SWAYAM). The course gives a brief history of evolution of the One Health approach, its application, relevance, and success. It covers topics such as Emerging Infectious Diseases and Antimicrobial Resistance, One Health Application in Management of Zoonotic Diseases, Applied Epidemiology & Public Health in One Health Research, and Health Policy. The 12-week course designed for the students, early career researchers, clinicians and policy makers aims to develop a trained human resource for effective management of emerging and re-emerging infectious diseases of public health importance. It will also introduce the concept of One Health at the community level, enhance recognition of the environment as a common space for humans and animals, and emphasize the need for a multi-sectoral approach in addressing diseases that are zoonotic in nature.⁶



- **Other initiatives:** ICMR-DHR, in collaboration with the Ministry of Health and NCDC, has prioritized a list of one health diseases for the proposed One Health Mission as part of PM - Ayushman Bharat Health Infrastructure Mission (PM-ABHIM) activities. ICMR-DHR is

working on laboratory algorithms to detect important zoonotic pathogens and other pathogens causing one health disease for early disease detection. The

organisation is also planning to conduct syndromic surveillance with a focus on domains where there is more human-animal and environmental interaction to detect pathogens that can affect humans from animals/birds and the environment.

Additionally, scientists across ICMR's institutes continually adopt a One Health lens in their research and interventions. In the past, this has played a significant role in containing viral outbreaks of Zika, Nipah and Canine Distemper. ICMR is also working to set up surveillance at animal-human interface, including in bird sanctuaries, zoos and slaughterhouses. For this purpose, extensive work has been undertaken to revise the laboratory algorithms for various syndromes.⁷ These algorithms have been modified to include bacterial, viral, fungal and parasitic organisms, as well as pathogens reported to have a zoonotic origin. ICMR and its institutes are also working at the state level to

strengthen surveillance against zoonotic infections. ICMR has, thus, demonstrated its intent to advance interdisciplinary research and is pioneering the development of new diagnostic tools, treatments, and vaccines for zoonotic diseases.

Drawing from these experiences, G20 countries can play a definitive role in promoting One Health within their territories. As major players and decision shapers in global health, the G20 must come together to jointly implement the One Health approach. This will entail addressing the root causes of zoonotic diseases, such as habitat destruction, deforestation, and wildlife trafficking.

One Health presents an opportunity to improve global health security, protect public health, and promote sustainable development. The time to act is now, and G20 countries led by India have a vital role in shaping our collective future. ■

G20 can transform lives across the globe by leveraging and complimenting the strengths of the member countries while arriving at solutions to address the diverse needs of the countries.

Taking forward this spirit, the 2nd Environment and Climate Sustainability Working Group Meeting (ECSWG) under India's G20 Presidency witnessed participation of 19 countries + EU participants from G20 countries, 9 invitee countries, and 12 international organisations.

The three-day meeting held in Gandhinagar, Gujarat from March 27-29, 2023 carried forward deliberations on the identified priority areas of Arresting Land Degradation,

Accelerating Ecosystem Restoration and Enriching Biodiversity; Pursuing Sustainable and Climate-Resilient Water Resource Management; Promoting a Sustainable and Climate-Resilient Blue Economy and Encouraging Resource Efficiency and Circular Economy. The G20 delegates displayed a sense of urgency towards battling the steep environment and climate challenges that the world is facing. Taking forward the discussions on the deliverables and the expected outcomes, the 3rd ECSWG meeting aims at focusing on negotiations which would ultimately be adopted in the concluding meeting.

The 2nd ECSWG, jointly led by the Ministry of Environment, Forests and Climate Change (MoEFCC) and Ministry of Jal Shakti (MoJS), focused on the holistic management of water resources, with a compendium of best practices for water resources management being prepared by the Ministry of Jal Shakti.

While sharing high appreciation for India's programmes on the subject, the delegates echoed the pressing need



for global action and scaling up of such initiatives to address the depleting level of groundwater at an alarming rate across the globe by leveraging the role of technology, cooperation and joint research and an integrated approach to water resource conservation and sustainable development, among others. The key points of discussion were included in the communiqué which will provide impetus to the agenda of the forthcoming meeting.

Ms. Darshana Vikram Jardosh, Hon'ble Union Minister of State for Railways and Textiles, Government of India, graced the occasion on the third and final day of the meeting in Gandhinagar with a special address to the delegates. She appreciated how the theme of 'Vasudhaiva Kutumbakam' has been adopted by India's G20 Presidency, which builds on the fact that the 'world is one family.' She acknowledged the comprehensive approach of the G20 countries to address climate change.

The opening remarks by Dr. M. Ravichandran, Secretary, Ministry of Earth Sciences (MoES) set the ball rolling for the technical sessions on Blue Economy.

The technical sessions on Biodiversity, Land Degradation and Ecosystem Restoration spread over Day 2 and Day 3 built on the key inputs collated from deliberations during the 1st ECSWG Meeting, the focus group discussions and the written inputs shared by the member countries. Shri Bivash Ranjan, Co-Chair, G20 ECSWG and lead for Biodiversity, Land



degradation and Ecosystem restoration, MoEFCC, opened the thematic sessions with engaging discussions amongst the delegates on the two priority landscapes identified under India's Presidency – the Gandhinagar Information Platform (GIP) and the proposed Gandhinagar Implementation Roadmap (GIR). The positive inputs received and alignment by the member countries at the land priority coupled with the inputs from the 3rd ECSWG will help in adoption of these documents at the Ministerial meeting to be held in July 2023.

Accelerating the implementation of the Kunming Montreal Global Biodiversity Framework across G20 countries was the highlight of the session. The broad consensus received on the priority and outcomes proposed in issue note was a step towards the next level of Virtual group discussion to be taken up before the next meeting.

The 3rd ECSWG meeting which is scheduled to take place in Mumbai from May 21–23, 2023 will host the Ocean 20 Dialogue to discuss the important topics like science, technology, policy, finance and community participation and their role in creating a sustainable climate resilient Blue Economy. On the sidelines of the Ocean 20 Dialogue a coordinated beach cleaning event has been planned for the G20 delegates on May 21, 2023 to emphasize

on the importance of action on marine litter and community participation. The outcomes of the Dialogue will flow into the High Level Principles being created under the Blue Economy priority. ■



Unlocking Full Potential of Women in Global Economy

EMPOWER, a G20 Alliance for the Empowerment and Progression of Women's Economic Representation, aims to accelerate women's leadership and empowerment in the private sector by leveraging its unique alliance among business leaders and governments. With the backing of business leaders and governments from each G20 member country, the alliance is ensuring that women become central to the discourse on economic and social progress.

Women make up half of the world's population and workforce, yet they continue to face significant barriers to participating fully in the global economy. Existing inequities mean that women continue to be under-represented in

decision-making roles across the public and private sector.

Today, equity is not just a moral issue, but a strategic imperative. Empowering women economically leads to increased productivity, higher profits, and stronger economic growth. If women play an identical role in labour markets to that of men, as much as \$28 trillion, or an additional 26% could be added to global annual GDP by 2025.

Overcoming barriers through EMPOWER

EMPOWER has identified three priority areas: women's entrepreneurship – a win-win for equity and economy; creating a global partnership to promote women's leadership, including at the grassroots; and education, including access to technology and digital skills. Through this, EMPOWER wants to move the needle from women development to women-led development.

Education

A UNICEF report highlighted that 90% of jobs worldwide have a digital component. However, in developing nations, there is still a 32.9% gap in internet access





between men and women.

To bridge the gender digital divide, EMPOWER is launching a Digital Inclusion Platform, envisioned to be an education and upskilling portal that will enable women across various geographies to gain basic digital, technical and financial knowledge that will be crucial for the jobs of the future.

Entrepreneurship

Even today, women tend to be less involved in entrepreneurship, and women-led enterprises are less likely to scale compared to businesses owned by men. EMPOWER is focusing on recommendations that can enhance financial inclusion and access capital for women, and bring more women in STEM roles.

A study by Cornell University found that mentoring programs dramatically improved promotion and

retention rates for women. With this in mind, we are launching a Mentorship Platform that will serve as a global mentoring and capacity-building portal while aggregating best practices among women mentees and mentors.

Leadership

When it comes to leadership, men still dominate positions of power. Women leaders are leaving their companies at the highest rate ever and the gap between women and men in senior roles quitting their jobs is the largest it's ever been. EMPOWER is addressing the gender leadership gap through five key areas: building a pipeline of women in the workforce, fostering an equitable and inclusive workplace, advancing women into leadership positions, promoting cross-border collaboration and knowledge-sharing, and supporting women-led enterprises at the grassroots level.

EMPOWER is contributing to women-led development by reshaping the narrative around women in the workforce, contributing to knowledge sharing through best practices in the EMPOWER Playbook, offering actionable private sector commitment and recommendations for the government through the Communiqué, and ensuring commitment to improvement by tracking data in our KPI Dashboard. In addition, with its network of EMPOWER Advocates, private sector leaders in positions to drive change, EMPOWER is focusing on converting recommendations into action.

The Global Gender Gap 2022 report estimates that it will take 151 years to attain gender parity in economic participation at the current rate of progress. Addressing this, the 2nd G20 EMPOWER meeting in Kerala emphasized the urgency of addressing the global gender gap. The time for change is now and EMPOWER is committed to making it happen through urgent, bold and transformative action. ■

Women 20 (W20) was established in 2015 during Turkey's G20 Presidency as the official G20 engagement group with the primary objective of promoting gender equity through women empowerment, advocating for their rights, and amplifying their voice in the society. The idea behind its creation was that domestic initiatives alone were insufficient to achieve significant progress towards gender equality, necessitating an international approach. In addition, the group aims to ensure that the G20 Leaders' Declaration incorporates measures and commitments that support gender equality and economic empowerment of women.

W20 India is strongly committed to its vision of creating

a world where every woman can live with dignity and equality, and is dedicated to its mission of eliminating barriers to women-led development while creating a supportive environment for women to thrive and transform their own lives and the lives of others.

To achieve this mission, W20 India has prioritised five key areas under the overarching aim of Women Led Development - Women Entrepreneurship, Grassroots Women Leadership, Bridging the Gender Digital Divide, Charting pathways through Education and Skill Development, and Women & Girls Eco-Changemakers for Climate Resilience.

The Women 20 Engagement Group, under India's Presidency, organized the 2nd Women 20 (W20) International Meeting in Jaipur, Rajasthan from April 13-14, 2023. The International Meet began with a *Jan Bhagidari* (People's Participation) event supported by Jaipur






